


VU's Participation in the THE Impact Rankings 2023

Furthermore, the faculty consistently contributes to the academic discourse by publishing a biannual peer-reviewed journal that delves into topics crucial for SDG 16. The Vishwakarma University Law Journal is a faculty run, biannual, blind peer reviewed journal of the Vishwakarma University Department of Law. The objective of this Journal is to contribute original, outstanding and socially relevant research to the Field of Law. It provides a platform for academicians, practitioners, researchers, scholars and students to share their views and make effective contributions to legal academia. VU Legal Aid Clinic

A. About

Student Team

The Faculty of Law was established under the Faculty of Law in 2018 as a centre for legal research and education. The department runs PhD, LLM, LLB and BBA-LLB programmes.

In line with Article 39A of the Constitution of India, which advocates for equal access to justice for all, regardless of their vulnerability based on factors like religion, race, caste, economic status, and place of birth, Vishwakarma University established the VU Legal Aid Clinic on October 26, 2021. The clinic welcomes students from the Faculty of Law and other academic disciplines to volunteer and engage in legal aid initiatives. This unique opportunity enables students to connect with diverse segments of society, gain insights into their specific legal challenges, and formulate legal remedies. The Legal Aid Clinic also conducts interdisciplinary research projects addressing socio-legal issues. It collaborates with nonprofit organizations and community-based groups to identify the distinct legal needs of marginalized populations. Additionally, the clinic collaborates with the judiciary and government agencies to enhance access to a broader range of cases and also partners with technology companies to develop digital solutions for legal issues.

B. Identify and engage with local stakeholder (policy if any)

Chapter IV of the Legal Services Authorities Act, 1987 enumerates the persons who are entitled to free legal services. As, the Legal Aid Clinic functions under the aegis of the National Legal Services Authority, we are committed to provide the services to these persons. Also, as far as the targeted population is concerned, the clinic targets vulnerable sections like women, children and elderly from the villages that are adopted by VU under the Unnat Bharat Mission and the Urban Slums around the campus of the university.

C. Meaningful mechanism for participation

The clinic conducts various outreach programs which facilitate direct engagement with marginalized individuals, providing legal assistance, information, and empowerment while addressing their specific legal needs. The clinic is also open in the office hours. Anyone can call or visit the clinic for free legal advice. Our helpline number is +91 8669908315.

D. Research and Advice to the government

The clinic has initiated research project with the Centre for Police Research and the proposal is under consideration. Also, we have initiated a project on 'Cyber Safety for Adolescents' after our experiences in the speed mentoring sessions that we conducted in the schools.

E. Neutral Platform for dialogue to come together and discuss issues frankly

Under Constitutional guidelines, free legal aid should be available to everyone irrespective of their vulnerabilities due religions, race, case, gender, place of birth, ethnicity etc. Law students and professionals at the clinic prioritize confidentiality, creating a safe space for individuals to openly discuss their legal concerns without fear of judgment or reprisal. This impartiality fosters trust and encourages individuals to seek assistance, making VU Legal Aid Clinic a reliable and open forum for addressing a wide range of legal issues with honesty and transparency.

F. Activities

1. International Conference On

"Women & Abusive Relationships: Challenges On Path To SDG 2030"

The International Conference was organized by Department of Law, Vishwakarma University, with consistent efforts of our faculty coordinators Dr. Padmaja Kathikar, Prof. Shruti Das, Prof. Divyanshu Priyadarshi, and contributions of other faculty members of Department of Law.

Over the two days of March 7th and 8th, 2022 the Department of Law, Vishwakarma University, brought together practitioners and academicians for a critical analysis of the abusive relationships a woman goes through. The Conference combined short presentations and lectures by specialists and experts with structured discussion sessions on the challenges and opportunities for Women in current society. The conference focused on the themes like abusive intimate relationship, addressing gender equality to meet the Sustainable Development Goals, 2030, mitigating abusive relationships and domestic violence, the role of social and feminist movements, role of media and representation of abusive relations and so on.

This conference provided an opportunity to bring attention to the issue of intimate partner violence, connect international experts, scholars, faculty and students for fostering an open discussion and showcase collective commitment to address the issue.

There were total 8 breakout rooms on the zoom platform, in every breakout room there was one faculty member and one student coordinator. There were a total number of 66 presentations which were conducted smoothly and a chairperson to review all the papers was present in each breakout room.

2. Visit to Lok Adalat

Students of VU Legal Aid Clinic, Department of Law visited the Pune District Court for observing the dispute resolution process of the National Lok Adalat on 12th March 2022. This visit highlighted the importance of community engagement and social justice. Law students can learn how legal professionals work to resolve disputes in ways that benefit the community, contributing to the broader goals of peace and justice in society. The students understood the importance of making justice accessible to all, how the institutions function learn the methods are employed to settle cases outside of the traditional court system, consider careers in ADR which are the core values of the SDG 16.







3. National Level Seminar on "Legal Services and its Scope"

VU Legal Aid Clinic and Pune DLSA organized a seminar on "Legal Services and its Scope". The seminar was conducted in VU Campus on 8th May 2022. The programme was graced by the presence of Honorable Shri Ashok Jain, Member-Secretary, NALSA, Honorable Shri D P Surana, Member-Secretary, MSLSA and Honorable Shri Pratap Sawant, Member-Secretary, DLSA, Pune, Prof. Dr. Siddarth Jabade, Vice Chancellor, Vishwakarma University, Pune and Prof. Dr. Wasudeo Gade, Vice President, Vishwakarma University, Pune

The speakers stressed on the works and success on NALSA (National Legal Services Authority). Further while highlighting the role of NALSA in coordinating and monitoring legal aid activities, they emphasized the role of the law schools and legal aid clinics in bridging the marginalized and the legal system, importance of equitable access to justice for all, and need for pro bono legal services.

4. Participation in National Level Legal Aid Competition.

Student team of VU Legal Aid Clinic won the Best All India Legal Aid Clinic Student Lawyer Team Award and cash prize of Rs. 10,000/- in the Prof. V S Mallar Memorial Legal Aid Competition organized by CEERA, NLSIU Bengaluru in association with Department of Justice, Government of India.

The university's initiatives, including village visits, Jan Sunwai events, mentoring on cyber awareness for children, and street plays on the rights of the elderly, have significantly contributed to law students' understanding and promotion of SDG 16 (Peace, Justice, and Strong Institutions).

Village visits and Jan Sunwai have exposed students to grassroots-level legal challenges, fostering a commitment to justice, accountability, and inclusivity (SDG 16.3). Mentoring on cyber awareness has equipped them with the knowledge to address emerging legal issues, emphasizing the importance of strong institutions in combating cybercrime (SDG 16.6).

Additionally, the street plays advocating for the rights of the elderly promote awareness of human rights and social justice, aligning with the principles of peace and inclusivity enshrined in SDG 16. Street plays serve as a powerful advocacy tool to raise community awareness, emphasizing the importance of transparency and accountability (SDG 16.6).

In sum, these activities have empowered law students to be advocates for justice, human rights, and strong institutions, actively contributing to the achievement of SDG 16 in their roles as future legal professionals.

4.1. Village Halt:

A team of 14 students and 2 faculty members visited and halted at the Mordari Village on 19th - 20th September 2022. Students interviewed almost 50 families and reached out to around 400 people in the village community to understand their legal challenges.







4.2. Street Play:

Students performed street plays on the topic right to education and rights of the elderly. In these street plays, the students explained various government schemes that the people can avail and informed about the Right to Information (RTI) and how that can be availed.







4.3. Jansunwai:

Jansunwai was conducted with the village residents to understand their legal concerns and issues. Around 70-80 people from the village community attended the sunwai and discussed issues related to public distribution system, documents, land issues, family partition issues, etc.







4.4. Speed Mentoring:

Speed mentoring for school students on the topipc 'Cyber Safety for Adolescents' was conducted in Zilla Parishad Schools as well as in Muktangan English Medium School in Pune. Around 2000 school students benefited from this activity. (29-30 September 2022)

5. Moot Court Competition

The Moot Court Committee of the Department of Law, Vishwakarma University, Pune successfully conducted its First Intra Moot Court Competition on 29th September 2022.

The Moot Problem given to the students revolved around conflict between right to live, right to die, and right to religion.

Participating in a moot court addressing issues such as the right to live, the right to die, and the right to religion offers law students a valuable perspective on SDG 16 (Peace, Justice, and Strong Institutions). It encourages students to grapple with complex legal and ethical dilemmas, promoting an understanding of the importance of justice and the rule of law (SDG 16.3). Furthermore, it highlights the significance of respecting diverse viewpoints and upholding individual rights, which contributes to building peaceful and inclusive societies (SDG 16.7). Engaging in such debates helps students develop the legal and advocacy skills necessary for advancing SDG 16's goals of ensuring access to justice and upholding human rights.

Prof. Divyanshu Priyadarshi, Faculty Coordinator of the Moot Court Committee excellently mentored the students about advocacy skills, courtroom manners, and so on. The team of Ms. Aditi Sharma and Ms. Igra Zainab (BBA-LLB, 4th Year) won the Moot Court Competition.



Farmer Producer Organizations: Communication in News Media - Theory and Practice A joint project of VU-CCD and Sahyadri Farms

To boost the agrarian economy, the government of India is promoting the Farmer Producer Companies to deal with issues related to scalability, farmer sustainability, and consumer benefits. However, these companies have not received adequate coverage in the mainstream media. To address this gap, Sahyadri Farms, (Farmer Producer Company established in 2010) located in Nashik, and Vishwakarma University (VU) have joined forces as research partners. They aim to conduct research that addresses the concerns of FPOs regarding their representation in the news media. This project holds significant importance because effective communication plays a pivotal role in disseminating information, building consensus, motivating the audience, and facilitating empowerment and developmental processes.


The centre conducts counseling sessions of the people who approach the centre and the centre maintains complete confidentiality of the same.
