## **Cancellation Policy:**

If the Hostel admission is cancelled within 10 days from the date of hostel admission, 10% of the total fee (hostel + mess) will be deducted.

- i. If the Hostel admission is cancelled within 20 days from the date of hostel admission, 20% of the total fee (hostel + mess) will be deducted.
- ii. If the Hostel admission is cancelled within 30 days from the date of hostel admission, 30% of the total fee (hostel + mess) will be deducted.
- iii. If the Hostel admission is cancelled after 30 days from the date of hostel admission, 100% of the total fee (hostel + mess) will be deducted.
