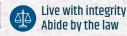

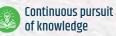

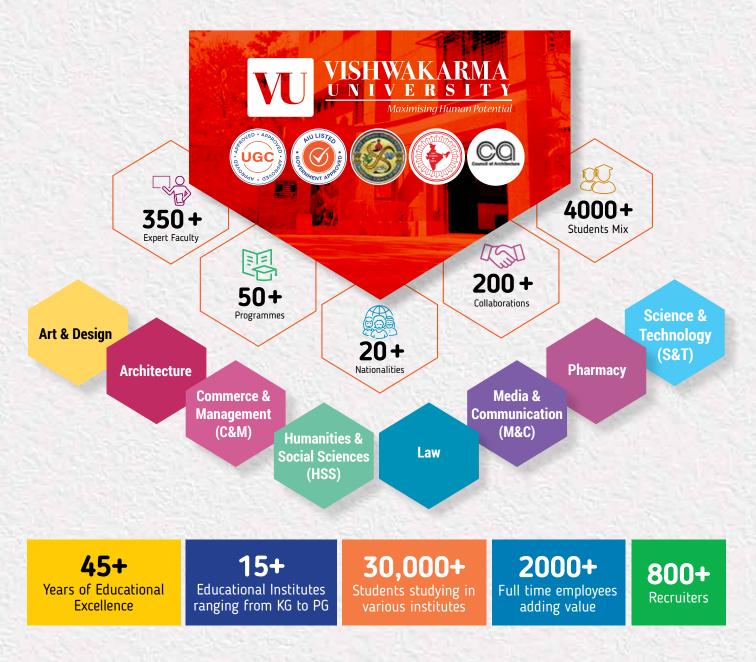

### Who is Eligible?

#### LLB

• Graduation in any discipline from a recognised university (Indian or foreign equivalent).

- 12th and three-year graduation are mandatory; 12th is the basic requirement.
- Graduation can be completed through UGC-recognised distance/correspondence/open schooling.
- Direct graduation from Open University without 10+2 is not eligible.
- Minimum passing percentage:
- 45% for General
- 42% for OBC, VJNT, SBC
- 40% for SC/ST

#### **BBA LLB**

- Completion of Senior Secondary (+2) or equivalent from a recognised board/institution in India or abroad
- Minimum qualification: 10th and 12th, with 10th as the basic requirement



- Qualifications (10th, 12th, or graduation) can be obtained through UGC-recognised distance/correspondence/open schooling, but:
- If 10th is completed through distance/correspondence, earlier schooling (1st to 9th) must also be completed
- If 12th is completed through distance/correspondence, a minimum 2-year gap between 10th and 12th is mandatory
- Minimum passing percentage:
- 45% for General
- 42% for OBC, VJNT, SBC
- 40% for SC/ST



#### Ph.D in Law

Vishwakarma University follows the eligibility criteria and procedures for admission to the Ph.D. programme as outlined in the University Grants Commission (UGC) Regulations, 2022. This includes the duration, admission process, allocation of research supervisors, course work, research advisory committee functions, evaluation methods, and minimum credit requirements for degree award. It also covers admission for international students, part-time Ph.D. options, issuance of provisional certificates, and depository with INFLIBNET.
