Student Notice

In view of recent news in the media regarding re-opening of the Universities and Colleges in Pune District, all the students of Vishwakarma University and their parents/guardians are hereby informed that the Vishwakarma University campus is already open for administrative activities and the administration is ready to resume academic activities in the campus.

Vishwakarma University will resume its academic activities on campus from 12-10-2021 by referring to the directives in the revised orders by Pune Municipal Commissioner dated 08-10-2021 and 09-10-2021.

As per the directives/instructions in these orders, the University campus will reopen with following conditions -

- 1. The students vaccinated with two doses of COVID19 prevention vaccine will be allowed in the campus.
- 2. Norms regarding COVID appropriate behavior like use of mask, social distancing and sanitization are mandatory to be followed in campus.

In view of these conditions, the students entering the campus for offline academics are informed to

- 1. Fill the Google form in the given link (uploading the valid Certificate of "Fully Vaccinated" in this form is mandatory)

- 2. Upload the duly filled and signed Consent form from parents/guardians (attached herewith) in the above mentioned Google form
- 3. Upload the duly filled and signed Undertaking (attached herewith) in the above mentioned Google form
- 4. Follow the instructions while in campus as per the Advisory (attached herewith)

The students are informed to carry two sets of the following documents (duly filled and signed) while coming to the campus and submit one copy in SFC and get another copy stamped from SFC-

- 1. Valid Certificate of "Fully Vaccinated"
- 2. Consent from parents/guardians
- 3. Undertaking

The students are informed to continuously carry the stamped copy of these documents while in campus and will be allowed to enter the buildings in the campus only after presenting the stamped copy at the building entry every time.

The online education using Vishwakarma Online Learning Platform (VOLP) is being continued without any hindrance and disruption till further notice. The academics (offline/blended) will be conducted as per the timetable that is being shared soon by the concerned Dean.
